- A complete set of bidding documents may be purchased during office hours on or **before 11st April**, **2018 (28 Chaitra, 2074 BS)** from the office of **Tansen Municipality, Tansen** or downloaded from the **PPMO's website**, by eligible bidders on the submission of a written application, **along with the copy of company/ firm registration certificate, tax clearance certificate up to FY 2073/ 074 and upon payment of a non-refundable fee of NRs. 3,000.00.** The Bidders may also prepare and submit the necessary bidding documents electronically through e-procurement section of PPMO's web site <a href="http://www.bolpatra.gov.np/egp">http://www.bolpatra.gov.np/egp</a>. The bidders who choose to purchase the bidding documents from the office, shall be required to deposit the cost of bidding document as specified above in the Municipality's Rajaswa (Revenue) account and those who choose to submit electronically, a copy of scanned bank deposit voucher (in .pdf format) shall also be submitted along with the electronic bid files.

- A pre-bid meeting shall be held at the office of Tansen Municipality, Tansen at 14:00 hours on 30th March, 2018 (16 Chaitra, 2074 BS).
- Sealed Bids must be submitted to the office of Tansen Municipality, Tansen on or before 12:00 hours
  on 12th April, 2018 (29 Chaitra, 2074 BS). Bids received after this deadline will be rejected.
  Alternatively, bidders may summit their bid electronically through e-procurement section of PPMO's
  web site <a href="http://www.bolpatra.gov.np">http://www.bolpatra.gov.np</a>. as specified in the instructions to bidders. Late bids will be
  rejected. Bidders who summit their bids electronically should summit hard copies (original printed
  copy) of those bids within 7 days from the date of bid opening.
- Sealed Bids will be opened in the presence of bidders' representatives who choose to attend at 13:00 hours on 12th April, 2018 (29 Chaitra, 2074 BS) for all contracts at the office of Tansen Municipality, Tansen. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the bid validity period. The original bid bond guarantee letter should be issued in the name of the office by any Commercial (Banijya) Bank, recognized by the Government of Nepal. Only the bid security guarantee letter in the format specified in the bid document will be accepted.
- If a bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in **Deposit Account No. 30303007102 at Nepal Rastriya Banijya Bank Branch Office, Tansen Palpa,** and the receipt of the deposited cash amount shall be submitted along with the bid.
- Bidders can bid as a single contractor or in the form of a joint venture of contracting firms necessarily registered under Government of Nepal. JV agreement and power of attorney must be submitted. The number of partners in the joint venture shall be limited to three.
- If the last date of bid purchasing, submission, opening and pre-bid meeting falls on a government holiday, then the date for the applicable event shall be extended to the next working day. In such case the validity of bid security shall be considered from the originally specified last date for bid submission.
- Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
- The bidders shall quote the item rate in the bill of quantities exclusive of VAT and submit VAT registration certificate at the time of agreement.
- Any conditions not covered so far shall be as per FAR 2056 (Latest Revision), Procurement Act 2063, and Procurement Regulation 2064 (fourth amendment 2073).
- Any amendment in this notice shall be pasted on the notice board of the client's office and PPMO's eprocurement website.
- Tansen Municipality Office, Tansen, Palpa reserves the right to accept or reject, wholly or partly, any or all the bids without assigning any reason, whatsoever.
